Community Engagement

The Davis Joint Unified School District (DJUSD) ESSER III plan was developed with community input from a diverse group of stakeholders. These groups include the District English Learner Advisory Committee (DELAC), Parent Advisory Committee of the Native American Education and Title XI Program, and Migrant Parent Advisory Council (MPAC). Included in the gathering of input were civil rights organizations such as the Mexican American Legal Defense Educational Fund (MALDEF) and Californians Together. In addition, stakeholder feedback from Local Control Accountability Plan (LCAP) and Expanded Learning Opportunities (ELO) were also referenced in the creation of this plan as referenced below.

DJUSD's ESSER III plan was informed by stakeholder input, including feedback given during ELO grant and LCAP stakeholder engagement activities. A cross section of community input was made accessible through the Superintendent's All Advisories Committee, which is composed of members from the following District committees: Parent, Student, District English Learner Advisory Committee (DELAC), District Technology Advisory Committee (DTAC), Climate, Certificated Personnel, Classified Personnel, Special Education, Native American, AIM (GATE), and Administrative Leadership Team. In February of 2021, the All Advisories involvement included a review of student performance, and structured feedback to elicit student successes and needs from the group. Additional outreach activities included school site focus groups led by principals, consultation with the Davis Teachers Association, consultation with district and site leadership, and student and parent surveys.

In April of 2021, the Superintendent's All Advisories and DELAC reviewed services and programs for consideration in the LCAP, and will review a completed draft document in May. Throughout winter and spring of 2021, the Superintendent's Parent Advisory and English Learner Parent Advisory were updated, surveyed, and able to review the draft LCAP. In February of 2020, data was shared with the Parent Advisory Committee of the Native American Education and Title VI Program and staff consulted with the Yolo County Office of Education SELPA.

DJUSD reviewed stakeholder feedback from the 2020-21 school year and analyzed resource allocations through funds other than ESSER III. Staff worked to align plans with the LCAP, Expanded Learning Opportunities Grant (ELO) and the ESSER III plan.

The DJUSD ESSER III plan includes actions and services in direct response to the feedback of students, staff, families, leaders, civil rights organizations, and community partners. As a result of stakeholder feedback regarding ESSER III prioritization, strategies for continuous safe in-person learning rated among the highest of priorities across all our stakeholder groups. The focus on weekly testing for COVID-19 at all sites and contact tracing as well as additional staff for supervision was positively received by our community and highlighted as things to maintain and further expand with ESSER III funds. DJUSD plans to continue the coordination of Covid-19 testing, purchasing of Personal Protective Equipment (PPE) materials, additional cleaning and sanitizing supplies including new air filters for the district to maximize physical health and safety measures at all sites. Our surveys also demonstrated that families want more outdoor learning areas. Families also shared that they believe additional technological resources for students may be needed in case of quarantine to mitigate disruption to academic skill development. Feedback specifically identifies a need for innovation and creativity, which resulted in the actions and services that promote professional development time toward Performance Assessments and curriculum design. DJUSD staff expressed the need for more collaboration time to implement our MTSS framework in order to address the needs of students experiencing academic, social, emotional and behavioral challenges. Every school will receive an allocation to support Multi-Tiered System of Support (MTSS) teams who will review data, identify evidence-based practices to support students, assign students to small group interventions, and identify additional professional development to support teachers. Additionally, stakeholder groups frequently shared a need for more culturally responsive pedagogy and an Ethnic Studies program. We will support and design professional development opportunities for staff and the implementation of Ethnic Studies through an advisory.

Additionally, students, families, teachers, and leaders requested flexible grading and more equitable practices for grading, which is the rationale for a District-wide focus on equitable grading strategies. Across advisories, we also heard that the secondary quarter block schedule was a success for deeper learning, focused student attention, and stress levels during 2020-21. As a result, DJUSD will explore scheduling structures that align to our values and shared vision for students.

Students, staff, and families noted in stakeholder outreach that DJUSD schools were in need of academic support for students, opportunities for students to find joy in learning, accelerate learning, and for data about their performance and progress. DJUSD will purchase i-Ready as a diagnostic tool to identify student skills, needs, and progress. Additionally, our LCAP includes summer program plans that are designed for engagement and practice of the Graduate Profile competencies. SELPA feedback specifically noted needs for diagnostics and summer offerings early for elementary grades.

Our stakeholders all identified the social emotional health of our students as a priority to support learning and community. As a result, an SEL screener was purchased, a contract was completed for Care Solace (a mental health concierge service), and counselors and nurses have been staffed at each site. The need for all families to understand district supports and structures has resulted in the creation of a position to coordinate family and community outreach .

Provision of an extra level of outreach is especially critical for our most vulnerable families that have been disproportionately impacted by the Covid-19 pandemic.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - Tracking student attendance and improving student engagement in distance education;
